MAS Resolution	E. Partch read aloud the MAS resolution regarding protests in and around the Standing Rock Sioux Reservation.

Public Comment:

Michael Peter, MSUN Student, Stockgrowers President	Representing MSUN Colligate Stockgrowers, Said that the club unanimously decided that it opposes the resolution, citing the damage the protest has caused to property of local farmers and ranchers. Also thought that we needed to support ND with mutual funding so they will support MT when we need help.
Cory Buckley, Student, RA,	No personal opinion regarding the pipeline. Opposed to the resolution
Former Senate VP	agreeing with the points made by stockgrowers. Said that the college should
	not be involved with political matters.
Sweetgrass Society	Said they "Stand with Standing Rock" and do not see this as a political issue,
	Stated that about 15% of students at MSUN identify as Native American, and
	want to make sure they are represented. Support the adoption of the MAS
	resolution.
