### Student Health Insurance

Health insurance is mandatory whenever you are enrolled for six or more academic credits. MSU-Northern offers comprehensive health insurance coverage to students at a reasonable rate. If a student has other coverage, a waiver must be signed and the premium will be reversed. Students without health insurance who wish to purchase it from the University must pay \$2304.00 for Fall 2021 and \$2304.00 for Spring Semester 2022. Payment of these two premiums results in coverage for 12 full months. Spring 2022 Semester-Only rate for new students is \$2688.00 (Coverage Period: 01/01/2022 – 07/31/2022).
