Student Health Insurance

Health insurance is mandatory whenever you are enrolled for six or more academic credits. MSU-Northern offers comprehensive health insurance coverage to students at a reasonable rate. If a student has other coverage, a waiver must be signed and the premium will be reversed. Students without health insurance who wish to purchase it from the University must pay \$2,192 for Fall 2025 and \$2,192 for Spring Semester 2026. Payment of these two premiums results in coverage for 12 full months. Spring 2026 Semester-Only rate for new students is \$2,557 (Coverage Period: 01/01/2026 – 07/31/2026).
