<u>Updates</u>:

New Provost, William Rugg, will begin on Monday, Feb 17. There will be a reception for Bill and his wife at 3:00 in the SUB Ballroom on Tuesday to welcome them to Havre.

Auto/Diesel campaign - is currently in the silent phase, which means that 70% of the funds needs are raised during this phase then the campaign will go public. The adjusted projection at this time is \$9.6 Million. Our portion to raise is \$5 Million. Once 3 million of that is secured we can break ground. Goal is to open in Spring 2016 for classes.

We Love Northern Ball - will be held February 15. Currently, \$28,000 for scholarships and over \$9,000 for the North Montana Plains Indian Museum has been raised.

North Montana Plains Indian Museum – work is continuing on the space in Library where the museum will be housed. A conservator will be on campus next week and a dedication ceremony will be held on Friday, May 2. The reception following Commencement will also be held at the museum.

NWCCU Accreditation - Chancellor gave handout to those present showing that accreditation for MSU Northern has been reaffirmed through NWCCU. There is still a need for improvement noted as follows:

- 1. Mission fulfillment indicators of achievement need to be better aligned with clearly defined and meaningful levels of mission fulfillment (Standard 1.A.1, 1.B.2);
- 2. Assessment Assessment efforts should place less reliance upon course-specific assessment and course grades, and a broader portfolio of assessment techniques should be developed and used (Standard 2.C.10);

Nursing – The Notice of Vacancy for the Director of Nursing position has recently been posted. The nursing department is conducting surveys for summer courses and tutoring to try and see what is most needed by their students. A report is due to State Board of Nursing every quarter. There is a taskforce being formed to address statewide nursing.

Dr. Cruzado will be on campus Feb 18 for meetings with Foundation and Alumni Boards and also lunch with faculty.

Title IX – Kim Watson reported that campus policies are being looked at to bring them under the 1MSU policy system. There are four Title IX investigators on the Havre campus. They are Kathy Jaynes, Kim Watson, Tracey Jette and Alisha Schroeder.
