6. NWCCU Report from Rosalyn

- 1. 2 handouts were given out.
 - Interpretation of Mission Fulfillment
 - Core Theme 1
 - Comprehensive Programs provide liberal arts, professional and technical programs that serve a diverse student population.
 - Objectives
 - Provide viable academic programs that are current and in demand.
 - Enhance teaching by increasing the number of faculty members participating in professional development activities.
 - o Indicators of Achievement
 - Implement Institutional Assessment Plans
 - SLAP and UCIP
 - 90% of programs and units completed
 - Conduct Program Prioritization of all minors and majors
 - Utilized th4e Board of Regents Academic Program Review Process
 - Compared means scores from one survey year to the next
 - Increase by 0.05 per year the number of faculty members participating in professional development activities to enhance their teaching.

Core Theme 2

- Student Success promote student centered and culturally enriched environment which fosters student success.
 - Objectives
 - Provide a student centered environment conductive to success.
 - Promote a culturally enriched learning environment.
 - Prepare students for careers in their chosen fields.
- Indicators of Achievement
 - Improve student first year to second year retention rate

- 53% fall 2012
- 56% fall 2013
- Increase 3% annually
- Improve student graduation rates
 - 4 year, 5 year and 6 year cohort groups by 1%, 2%, and 2% respectfully
- o To assess progress in developing a student centered environment
 - To assess progress in developing a culturally enriched environment
 - Means scores from one survey year to another –
 2011-2012 will be compared
 - Assess career preparedness using cooperative education employer and graduation surveys.

• Core Theme 3

- o Inclusive Partnerships partner with external entities to enhance and expand learning experiences.
 - Objectives
 - Expand student's opportunities or external learning experiences.
 - Use external partnership input to develop or enhance programs.
- o Indicators of Achievement
 - Increase the number of classes that have out-of-class experiences
 - Compare to the previous year using the baseline number of 112
 - Until 50% of all courses have out-of-class experiences
 - Use the NSSE Benchmarks of Active and Collaborative Learning (ACL)
 and Enriching Educational Experiences (EEE) for 2011 and 2012
 - Increase student engagement scores by 0.5 on NSSE, Benchmarks of ACL and EEE
 - Increase the number of advisory boards for programs by one (1)
 - Compared to previous year using 10 boards as base
 - Use input from advisory boards to enhance programs as evidenced by qualitative examples each year from 80% of partners.
