

ARTICULATION AGREEMENT

Offered collaboratively by MONTANA STATE UNIVERSITY-NORTHERN

and

GREAT FALLS COLLEGE MONTANA STATE UNIVERSITY ASSOCIATE of ARTS DEGREE with EDUCATION COURSEWORK

for

BACHELOR of SCIENCE in EDUCATION ELEMENTARY EDUCATION

I. Scope of the Program

MONTANA STATE UNIVERSITY-NORTHERN (MSUN) and GREAT FALLS COLLEGE MONTANA STATE UNIVERSITY (GFC MSU) hereby establish an articulation agreement leading to the BACHELOR of SCIENCE in EDUCATION, ELEMENTARY EDUCATION. This degree will be conferred by MONTANA STATE UNIVERSITY-NORTHERN.

II. Length of Agreement

This RENEWED agreement will begin FALL SEMESTER 2021 to continue for a minimum of four (4) years. The parties to this agreement commit to offering this program until it is dissolved by mutual agreement. The parties commit to a review every other year (next review, Fall Semester 2023). The next renewal agreement will be due Fall Semester 2025.

III. Course Articulation

Students completing the ASSOCIATE of ARTS DEGREE with EDUCATION COURSEWORK at GFC MSU will be granted SIXTY semester credits toward a BACHELOR of SCIENCE in EDUCATON at MSUN, as prescribed in this agreement. Students must have 39 credits at the upper division (300/400) level and 128 semester credits required to complete the bachelor's degree program. Upon completion of the following courses as shown in Exhibit A and the meeting of all graduation requirements including the general education requirements as shown in Exhibit B, a BACHELOR of SCIENCE in EDUCATON will be awarded from MSUN. Exhibit C provides an overview of General Education and Elementary Education program course equivalencies.

Western Undergraduate Exchange:

The Western Undergraduate Exchange (WUE) is a program of the Western Interstate Commission for Higher Education (WICHE). Through WUE, students in qualifying states may enroll in many 2-year and 4-year college programs at a reduced tuition level - approximately 150 percent of the institution's regular resident tuition. All degree programs at MSUN and GFC MSU are open to WUE students. WUE students transferring from GFC MSU to MSUN will need to reapply for WUE status with MSUN.

V. MSUN ADMISSIONS POLICY AND REQUIREMENTS

Admissions requirements for MSUN are as follows:

- 1. Completed Seamless OneMSU transfer application for admission submitted to MSUN;
- 2. All degree-seeking students or students carrying seven (7) or more credits, who are born on or after January 1, 1957, must provide evidence that they have received two measles and two rubella immunizations, with dose one administered at 12 months of age or later and dose two administered at least 28 days after dose one. No measles vaccination before 1967 is valid. No rubella vaccination before 1969 is valid. As an alternative, a student may supply a laboratory report from a CLIA approved laboratory indicating that the student is immune to measles and/or rubella. Students may be exempt from the above requirements for religious reasons providing the student files a notarized religious exemption or for medical reasons providing the student supplies a statement from a physician holding a license to practice in the U.S. or Canada stating the immunization that is contraindicated, the time period the immunization is contraindicated, and the reasons for the contraindication;
- Official academic transcripts from all accredited universities, colleges, and vocational technical centers attended. Official college transcripts must be sent to the Registrar's Office in a sealed envelope directly from the institution; and
- 4. Transfer applicants must present at least a 2.0 cumulative grade point average (i.e. equivalent to a "C" on a 4.0 scale), based on transferable credits carried from all colleges or universities previously attended to be eligible for full admission to a four-year campus.

VI. FINANCIAL AID

All enrolled MSUN students are eligible to apply for financial aid at MSUN. Each student's situation will be evaluated on an individual basis. Once admitted to MSUN, students must apply for financial assistance through MSUN's Financial Aid Office. https://www.msun.edu/finaid/
